

- 1. Any eligible bidder or their representative shall register with the Range Office with copies of their valid trade license and must produce a letter of authorization from the registered party/firms/individual in case a representative is participating in the auction.
- 2. The interested bidder shall deposit a non-refundable registration fee of Nu. 2000.00 (two thousand) at least one day prior to the notified auction date. The registration of bidders will not be entertained on the same day of the auction date.
- 3.
