

### TERMS AND CONDITIONS

1. Any eligible bidder or their representative shall register with the Division Office with copies of their valid trade license and must produce a letter of authorization from the registered party/firm/individual in case a representative is participating in the auction.
2. The interested bidder shall deposit a non-refundable registration fee of Nu. 2000.00 (two thousand) at least one day prior to the notified auction date. The registration of bidders will not be entertained on the same day of the auction date.
3. A sum of Nu. 70,000.00 (seventy thousand) should be deposited as a security deposit at the time of registration in the form of a demand draft in favor of the Chief Forestry Officer, Pema Gatshel Division. The bid security of unsuccessful bidders shall be refunded on the same day. However, the bid security of the winning bidder(s) shall be retained and refunded only upon complete lifting of the allotted products.
4. All bidders/representatives participating in the auction shall be assumed to have inspected and satisfied themselves with the quality and quantity of products available. The auction committee shall not be held liable for any limitations in quantity and quality of products after the auction.
5. The highest bidder/representative whose bid has been accepted on the fall of the hammer shall be allotted the products. In the event the auction committee disqualifies the highest bidder, the committee will allot the product to the second-highest bidder. The decision of the auction committee shall be final and binding.
6. The winning bidders shall weigh the products jointly with the sellers in the presence of auction committee members for transparency and a clean record.
7. The winning bidder(s) shall pay 100% bid amount for the products on the day of the auction before transporting from the auction site. Failure to pay the total bid amount on the day of the auction, the accepted bid shall be cancelled, and the security deposit shall be forfeited. The committee shall award the products to the second-highest bidder.
8. The successful bidder shall lift the consignment on the same day, and this office shall not be held responsible for the loss or damage of the products.
9. Any complaints regarding the auction will be dealt with by the auction committee, and the decision of the committee shall be final and binding.
10. The successful bidder shall be responsible for obtaining necessary permits via [ofs.dofps.gov.bt](http://ofs.dofps.gov.bt) and bear any applicable costs.
11. The winning bidder should pay the applicable royalty for the respective products.
