### Terms and condition

- 1) Any Bhutanese national with valid CID shall be eligible to participate in the auction.
- 2) Any interested bidder will have to pay Nu.1000.00 (Ngultrum one thousand only) as Registration Fee which shall be non- refundable and obtain a token.
- 3) Any representative/s can register and avail the token on behalf of other interested bidder who cannot join the auction.
- 4) Every bidder shall be required to deposit an EMD of Nu 10000.00 (Ten thousand only) in the form of Demand Draft or Cash Warrant addressed to the Chief Forestry Officer, Divisional Forest Office, Sarpang.
- 5) The highest bidder shall deposit 50% of the bid price on the auction day.
- 6) The highest bidder shall take over the consignment after payment of the bid price.
- 7) The balance 50% of the bid price shall be paid within 10 (TEN) working days from the day of the auction before 4PM. Failure to pay within the stipulated duration, the accepted bid shall be canceled and deposits of 50% (Fifty percent) of the bid price shall be forfeited.
- 8) The successful bidder shall lift the consignment on the same day and this office shall not be responsible for loss/damage of the consignment.
- 9) Any complaint regarding auctioning will be dealt by the auction committee and the decision of the committee shall be final.
- 10) The successful bidder shall be responsible to obtain necessary permits via ofs.dofps.gov.bt and bear any cost.
- 11) Further trade of the consignment shall be allowed after fulfilling the requirements of all the agencies concerned.
