Notification of Open Auction for Special Class Timber

Divisional Forest Office, Dagana, would like to notify all interested individuals or parties on an open auction of seized special class timber. The auction will be held on July 29, 2024, at the Division head office in Dagapela at 11 A.M. The timber will be auctioned on an "as is where is" basis. All interested individuals are encouraged to inspect the timber during office hours prior to the auction.

To participate in the auction, individuals or parties must submit a security deposit of Nu. 5,000.00 (three thousand only) payable to the Chief Forestry Officer, Dagana Divisional Forest Office before the auction in the form of Demand Draft or Cash Warrant. The security deposit of unsuccessful bidders will be returned on the same day after the auction, while the deposit of the successful bidder will be returned upon full payment and lifting of the timber.

Terms and Conditions:

1. Any Bhutanese national with valid CID is eligible to participate in the auction and must deposit a non-refundable registration fee of Nu. 1000.00 at least one day prior to the auction day.
2. The successful bidder shall deposit 50% of the total bid value on the day of the auction and the remaining 50% after completing the extraction of 75% of the allotted timber.
3. The successful bidder shall be responsible for obtaining necessary permits via ofs.dofps.gov.bt and bearing any applicable cost.
4. In the event of a successful bidder withdrawing the work before completion, the CFO shall forfeit the 50% bid value deposited, and the site shall be put up for subsequent auction. The bidder will be barred from participating in future auctions.
5. All bidders shall report to Divisional Forest Office, Dagana, during office hour to inspect the timbers at the site.
6. The successful bidder should lift the timbers within 10 days from the day of allotment. However, if the work cannot be completed within the allotted timeframe, the bidder should inform the CFO for further course of action.
7. The successful bidder will be liable for penalty as per the existing relevant Acts and Rules in case of breaching any of the above terms and conditions.
