
Auction Notice

The auction is scheduled to take place on **4th September, 2024 (Wednesday) at 10.00 am within the premises of Panbang Range Office, Panbang under Zhemgang Dzongkhag.**

To participate in auction, all the interested bidders must register and obtain tokens. Registration and token issuance will commence from 21st till a day prior to the auction day during office hours. Please note that token issuance and consignment inspection will not be entertained on the same day of the auction.

Bidders are requested to inspect the consignment before the date of the open auction. Furthermore, bidders are advised to go through the "Terms and Conditions" provided below. Please be aware that any complaints raised after the auction will not be addressed.



Terms and conditions

- 1) Any Bhutanese national with valid CID shall be eligible to participate in the auction.
- 2) Any interested bidder will have to pay Nu.1000.00 (Ngultrum one thousand only) as Registration Fee which shall be non- refundable and obtain a token.
- 3) Any representative/s can register and avail the token on behalf of other interested bidder who cannot join the auction.
- 4) Every bidder shall be required to deposit an EMD of Nu 5000.00 (Five thousand only) in the form of Demand Draft or Cash Warrant addressed to the Range Officer, Panbang Range Office, Panbang Dungkhag.
- 5) The highest bidder shall take over the consignment after payment of the bid price.
- 6) The highest bidder shall deposit 50% of the bid price on the auction day.
- 7) The balance 50% of the bid price shall be paid after completing extraction of 75% of the allotted timber.
- 8) Failure to pay within the stipulated duration, the accepted bid shall be canceled and deposits of 50% (Fifty percent) of the bid price shall be forfeited.
- 9) The successful bidder shall lift the consignment on the same day and this office shall not be responsible for loss/damage of the consignment.
- 10) Any complaint regarding auctioning will be dealt by the auction committee and the decision of the committee shall be final.
- 11) The successful bidder shall be responsible to obtain necessary permits via ofs.dofps.gov.bt and bear any cost.
- 12) Further trade of the consignment shall be allowed after fulfilling the requirements of all the agencies concerned.
