Terms and condition

- 1) The bidders will pay Nu.1000.00 (One Thousand) only as registration fee which shall be non- refundable.
- 2) Bidder or any representative/s can register and avail a token on behalf of the registered bidder/s one day before auction date.
- 3) Highest price bidder will be selected in each category and hand over the consignment.
- 4) Accepted top most bidder shall deposit 50% spot payment in cash of the bid value at the fall of the hammer.
- 5) Product shall be re-weight in presence of winning bidder to ascertain actual quantity for payment on auction day.
- 6) Final payment must be made in the form of cash or demand draft in favor of the Offtg. Chief Forestry Officer, Divisional Forest Office, Gedu, Ministry of Energy and Natural Resources from Bank of Bhutan, Gedu.
- 7) The winning bidder will accepted by the auction committee and shall lift product on the auction day or next day after making full payment.
- 8) In case, the winning bidder fails to lift, Divisional forest Office, Gedu will not be responsible for any lost or damage of product.
- 9) Failure to pay within stipulated days or time, the accepted bid shall be cancelled and deposits of 50% (Fifty percent) of the auction value shall be forfeited.
- 10) Any complain regarding auctioning will be dealt by auction committee and decision of the committee will be final.
- 11) The winning bidder will apply on line for Permit and other Documents required for transportation of mushroom from auction site to market.
