



Terms and Conditions

1. The interested individual/parties must have valid logging licenses that are registered with our Division and must produce during the time of registration.
2. Interested bidder must inspect and verify forest produce at the site given above in consultation with Range Officer, Tshimasham during office hours before the auction date.
3. The interested bidder shall deposit an amount of **Nu. 5000/- as Earnest Money Deposit (EMD)** at the time of registration in Demand Draft/Cash in favor of Chief Forestry Officer, Gedu on or before **05:00 PM of 14/10/2024**. The EMD shall be refunded to the unsuccessful bidder. However, the EMD of the successful bidder shall be retained until the entire bid value is deposited.
4. The successful bidder shall deposit 50% of the bid value on the auction day and the remaining 50% before the issuance of coupe clearance by the concerned CFO.
5. In the event of a non-deposit of bid value on the auction day, the site will be allotted to the next highest bidder.
