Jigme Singye Wangchuck National Park (JSWNP) would like to invite Expression of Interest (EoI) from eligible Bhutanese firms including private parties on the following scientific thinning (logging) operations under the jurisdiction of JSWNP:

The following criteria should be met to be eligible to register for allotment:

- Possess valid Business license wood-based industries license (Primary or secondary);
- Registered with the Department of Forest and Park Services and possess valid registration certificate.
- Produce evidence of ownership or authorized hire of at least one cable crane; In case of hired cable crane, the cable crane must not be hired to multiple parties;
- Produce a valid coupe clearance issued by concerned CFO, if applicable.
- Private party shall not have been be allotted with more than one scientific thinning sites at a time.

The allotment will be done by the Scientific Thinning Allotment Committee tentatively on 10th December 2024 (Tuesday) at the Division headquarter in Tshangkha, Trongsa at 9.30 am on Lucky dip system. All interested parties are requested to register prior to this date to participate in the allotment process. To register contact 17543006/17270718.
