1. Must have a valid wood-based industry license (Primary/Secondary).
2. Registered with the Department.
3. Produce evidence of ownership or authorized hire of at least one cable crane. In case of hired cable crane, the cable crane must not be hired by multiple parties and shall produce a letter of authorization to use the cable crane from the owner.
4. Must have completed all the extraction works in the previous scientific thinning operation areas, if any, and produce a valid coupe clearance issued by the concerned CFO.
