## **Terms and Conditions**

- 1. Any Bhutanese national with valid CID is eligible to participate in the aution and must deposit a non-refundable registration fee of Nu. 1000 at least one day prior to the acution day.
- 2. The successful bidder shall deposit 50 % of the total bid on the day of the auction and the remaining 50 % after completing the exaction of 75 % of the allotted timber.
- 3. The successful bidder shall be responsible for obtaining necessary permits via. Ofs.dofps.gov.bt and bearing any applicable cost.
- 4. In the eventof successful bidder withdrawing the work before completion, the CFO shall forefeit the 50% bid value deposited, and the site shall be put for subsequent auction. The bidder will be barred from participating in future auctions.
- 5. All bidders shall report to the Divisional Forest Office, Bumthang during office hour to inspect the timber at the site.
- 6. The successful bidder has to remove all prime timbers and lops and tops from the site and dispose as deemed appropriate in any form by the bidder.
- 7. The successful bidder should lift the timbers within 14 days from the day of allotment. However, if the work cannot be completed within the allotted timeframe, the bidder should inform the CFO in writing for time extention in case of unavoidable cases only.
- 8. The successful bidder will be liable for penalty as per the rxisting relevant Acts and Rules in case of breaching any of the above terms and conditions.
