Terms and Conditions

- 1. Based on the notification, interested buyers can inspect the products to be disposed of in consultation with the Divisional Forest Office, Pema Gatshel.
- 2. On registration, potential buyers must pay a fee of Nu. 1000.00 to the Divisional Forest Office, Pema Gatshel. However, the registration fee will be returned to the unsuccessful bidders after deducting Nu. 150.00. The deducted amount of Nu. 150.00 will be used to meet refreshment expenses for the committee and the participants.
- 3. A winning bidder shall opt to make full payment OR an advance of 20% of the total sale value on the declaration of the bidding results. However, the remaining 80% of the sale value must be paid before lifting the products, which is within 30 days from the date of disposal.
- 4. In case the products sold are not lifted within the stipulated time period, the products will be resold to another buyer wherein the 20% advance payment made shall be forfeited.
- 5. In case the winning bidder fails to lift the products within the time period, the Divisional Forest Office, Pema Gatshel will not be responsible for any loss or damage of products.
- 6. The disposal of forest products can proceed in any selling modalities even if a single buyer participates.
- 7. A receipt for advance payment of the total sale value shall be issued instantly by the concerned HQ Range Officer but other documents required for the transaction of forest products shall be issued only upon receiving the total sale value.
- 8. The winning bidder shall apply online for a permit and other documents required for transportation from the auction site to the market.
