**Terms and Conditions:**

1. Any Bhutanese citizen holding a valid CID is eligible to participate in the auction. A non-refundable registration fee of Nu. 500/- (Ngultrum Five Hundred only) must be deposited at least one day before the auction date.
2. The registered bidder or representative shall avail a Token, a day prior to the auction date to participate in the open auction.
3. The successful bidder is responsible for obtaining all necessary permits via [ofs.dofps.gov.bt](http://ofs.dofps.gov.bt) and covering any associated costs.
4. If the successful bidder withdraws after the auction, the security deposit amount will be forfeited by the CFO.
5. All interested bidders must report to the Division Head Office, Zhemgang during office hours for any physical enquiries.
6. The successful bidder shall lift the forest produce within one month after completion of the auction. In case the task cannot be completed within the given timeframe, the bidder must inform the CFO for further instructions.
7. The respective Division or Park Offices shall not be responsible for any loss, damage, misplacement or deterioration of the forest produce.
8. Any complaints arising during the auction shall be dealt by the auction committee members and the decision of the committee shall be final and binding.
9. The trade of the consignment shall be allowed after fulfilling the requirements of the agencies concerned.
10. Any violation of the above terms and conditions will result in penalties in accordance with the relevant existing Acts and Rules.
