Terms and Condition

- 1. The interested individual/parties must have valid logging license that are registered with the Division and must produce a WBI Registration Certificate along with logging license during the time of registration.
- 2. Interested bidders must inspect and verify forest produce at the site mentioned above in consultation with the Park Range Officer, Chokor Park Range, Thangbi during office hours before the auction date.
- 3. WCNP, Bumthang shall not entertain the complains related to timber volume and quality once it is allotted through auction
- 4. All potential bidders must fill up the registration form or register before 10.30 AM on the day of auction.
- 5. A registration fee of Nu. 300/- (Non-refundable) with an earnest money (EMD) of Nu. 5000/- shall be deposited in Cash/Online Payment not later than 10.30 AM on the auction day.
- 6. The EMD shall be refunded to the unsuccessful bidder, However, the EMD of the successful bidder shall be retained until the entire bid value is deposited.
- 7. The successful bidder shall deposit 50% of the bid value on the auction day and the remaining 50% before the issuance of the coupe clearance by the concerned CFO.
- 8. In the event of a non-deposit of bid value on the auction day. The site will be allotted to the next higher bidder.
