Notification of Open Auction of Timber

Divisional Forest Office, Bumthang is pleased to notify on an "open auction of A and B class timber along proposed alignment of the 11 kV transmission line for the Mineral Water plant at Gaytsa, Chumey and 33kV transmission line from Gaytsa to Unsung, Chumey" to all interested individuals or parties. The auction will be held on 09/09/2025 at Divisional head office, Bumthang at 11 AM. The timber will be auctioned on "as is where is" basis. All interested individuals/ parties are encouraged to inspect the timber at site during office hour prior to the auction.

Terms and conditions

- Any Bhutanese national with valid Wood-Based Industry license that are registered with the concerned Divison/Park office is eligible to participate in the auction and must deposit a non-refundable registration fee of Nu. 1000/- atleast one day prior to the auction day.
- 2. The successful bidder shall deposite 50% of bid value on the day of auction and the remaining 50% prior to the issuance of coupe clearance by concerned CFO
- 3. The successful bidder shall be responsible for obtaining necessary permit via ofs.dofps.gov.bt and bearing any applicable cost
- 4. In the event successful bidder withdrawing the work before completion, the CFO shall forefeit the 50% bid value deposited and the site shall be put for subsequent auction. The bidder will be barred from participating in future auctions.
- 5. All the bidder shall report to the Divisional Forest Office, Bumthang during office hour to inspect the timber at site.
- 6. The successful bidder shall lift all prime timber and lops and tops from the site and dispose as deemed appropriate in any form by the bidder
- 7. The successful bidder shall lift the timber within 14 days from the day of the allotment. However, if the work cannot be completed within the allotted timeframe, the bidder should inform CFO in writing for time extension in case of unavoidable cases only.
- 8. The successful bidder will be liable for penalty as per the existing relevant Acts and Rules in case of breaching any of the above terms and condition
