
### Open Auction Notice



**Terms and Conditions:**

1. Any Bhutanese citizen holding a valid license for Wood Based Industry is eligible for open auction.
2. The interested parties shall conduct physical verification of extraction site prior to registration for open auction.
3. The interested parties shall register with a non-refundable registration fee of Nu. 500/- (Ngultrum Five Hundred only) at least one day before the auction date.
4. The interested parties shall deposit an amount of Nu. 5000/- as Earnest Money Deposit (Original copy) in Demand draft/Cash warrant at the time of registration. The EMD shall be refunded only to the unsuccessful bidders at the closure of auction.
5. The registered bidder or representative shall avail a Token, a day prior to the auction date and participate in the auction.
6. If the successful bidder withdraws after the auction, the security deposit amount shall be forfeited by the CFO, Zhemgang.
7. Any complaints arising during the auction shall be dealt by the auction committee members and the decision of the committee shall be final and binding.
