## **AUCTION NOTICE**

Divisional Forest Office, Wangdue, will be conducting an open auction to dispose of **69.86** CFT of seized timber (*Juglans regia*.) on **29**<sup>th</sup> of **October 2025** at the Meeting Hall, Divisional Forest Office, Lobesa starting at **2:15 PM** on "**As is Where is Basis**". Interested individuals and parties are welcome to participate in the auction. Prior to the auction, interested parties are requested to inspect the timber at Nobding Forest Range Office during office hours.

## **Terms and Conditions**

- 1. All Bhutanese individual with 18 years and above can participate. Interested individuals are required to produce valid CID for verification on the day of auction.
- 2. Interested individuals must complete registration before 11:00 AM on the day of auction.
- 3. A registration fee of Nu. 200 (Non-Refundable) with earnest money of Nu. 2000 shall be deposited in the form of cash not later than 11:00 AM on the auction day.
- 4. Earnest money of the unsuccessful bidder shall be refunded.

- 5. The highest bidder, whose bids are accepted, shall have to deposit a spot payment of 25% (in cash) at the hammer price and balance 75% (in cash) within 10 days from the date of auction.
- 6. All applicable fee and charges payable to the relevant agency or authority shall be borne by the successful bidder.
- 7. Failure to deposit 25% sale value as provided in clause 5 shall render the sale invalid, confiscate the earnest money (Nu. 2000) and the purchaser shall be debarred from further participation in the auction.
- 8. The purchaser shall not be entitled to possession of the timber until the total payment of the bid value. In the event the purchaser fails to make full payment within 10 days, EMD and 25% of the payment as specified in clause 5 shall be forfeited and the lot so affected shall be resold at the discretion of the committee.
- 9. The Bidder shall be deemed to have **physically inspected the timber** to their full satisfaction before bidding.
