Terms and Condition

- 1. Any Bhutanese citizen holding a valid license for Wood Based Industry is eligible for open auction.
- Interested bidders must inspect and verify forest produce at the site mentioned above in consultation with the Park Range Officer, Chokor Park Range, Thangbi during office hours before the auction date.
- 3. The interested parties/individuals shall register with non-refundable registration fee of Nu. 300/- (Three hundred) at least one day before the auction date.
- 4. The registered bidders or representative shall avail a Token a day prior to the auction date and participate in the auction.
- The interested parties/individuals shall deposit an earnest money (EMD) of Nu. 5000/- in Demand draft/cash warrant at the time of registration.
- The EMD shall be refunded to the unsuccessful bidder, However, the EMD of the successful bidder shall be retained until the entire bid value is deposited.
- 7. If the successful bidder withdraws after the auction, the security deposit amount shall be forfeited by the CFO.
- 8. The successful bidder shall deposit 50% of the bid value on the auction day and the remaining 50% before the issuance of the coupe clearance by the CFO, WCNP.
- 9. In the event of a non-deposit of bid value on the auction day. The site will be allotted to the next higher bidder.
