Notification of Open Auction of Timber

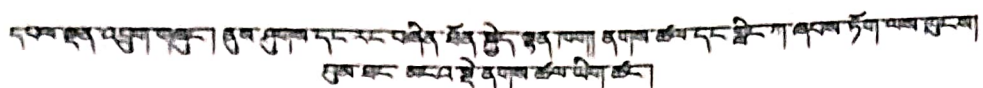
Divisional Forest Office, Bumthang is pleased to notify on an “open auction of special class timber within the premises of Bhutan Construction and Transport Authority, Trongsa that posses potential future hazard and open auction of Special class, A class and B class timber from Right of Way (RoW) clearance of the 33 kV transmission line from Yotongla to Gaytsa” to all interested individuals or parties. The auction will be held on 05/11/2025 at Divisional head office, Bumthang at 10 AM. All interested individuals/ parties are encouraged to inspect the timber at site during office hour prior to the auction.

Terms and conditions

1. Any Bhutanese national with valid Wood-Based Industry license that are registered with the concerned Divison/Park office is eligible to participate in the auction and must register with the CFO atleast one day prior to the auction day providing their trade license, Registration certificate and power of Attorney letter (if a representative is participating).
2. An amount of Nu.5000/- shall be deposited as earnest money in the form of cash warrant or demand draft at the time of registration to qualify themselves for participating in the auction.
3. The successful bidder shall deposite 50% of bid value on the day of auction and the remaining 50% prior to the issuance of coupe clearance by concerned CFO
4. The successful bidder shall be responsible for obtaining necessary permit via ofs.dofps.gov.bt and bearing any applicable cost
5. In the event successful bidder withdrawing the work before completion, the CFO shall forfeit the 50% bid value deposited and the site shall be put for subsequent auction. The bidder will be barred from participating in future auctions.
6. All the bidder shall report to the Divisional Forest Office, Bumthang during office hour to inspect the timber at site.
7. The successful bidder shall lift all prime timber and lops and tops from the site and dispose as deemed appropriate in any form by the bidder
8. The successful bidder shall lift the timber within 2 months from the day of the allotment. However, if the work cannot be completed within the allotted timeframe, the bidder should inform CFO in writing for time extension in case of unavoidable cases only.
9. The successful bidder will be liable for penalty as per the existing relevant Acts and Rules in case of breaching any of the above terms and condition
