AUCTION NOTICE

The Divisional Forest Office, Wangdue, hereby notifies all interested bidders that an open public auction shall be conducted for the disposal of items consisting of **162** pieces of Corrugated Iron Sheets and **two (2) truckloads** of timber from dismantled structures at Lobesa.

The auction shall be held on **27th February 2026** (Friday) at 2:00 PM at the **Meeting Hall** of the **Divisional Forest Office**, Lobesa, Punakha.


Interested bidders are required to **register by 11:00 AM** on the day of the auction at the Divisional Forest Office, Lobesa. Bidders are encouraged to inspect the auctioned items, which are retained within the Division Office compound, **prior to the date of auction**.

Bidders are advised to carefully read and understand the Terms and Conditions provided below. Any complaints raised after the auction shall not be entertained.

Terms and Conditions

1. Each bidder shall register and deposit a performance security of Nu. 3,000.00 (Nu. Three Thousand only) in cash, refundable, not later than 11:00 AM on the day of auction.
2. All bidders shall pay an entrance fee of Nu. 200.00 (Nu. Two Hundred only) in cash, which shall be non-refundable.
3. The performance security of the successful bidder shall be adjusted against the auction value. The performance security of unsuccessful bidders shall be refunded on the same day after completion of the auction.
4. The successful bidder shall make payment of at least 25% of the auction value immediately upon the fall of the hammer.
5. The remaining 75% of the auction value shall be paid within ten (10) working days from the date of auction. Failure to settle the payment within the stipulated period shall result in cancellation of the accepted bid and forfeiture of the advance payment.
6. The successful bidder shall lift the auctioned items within ten (10) days from the date of full payment. Failure to do so shall attract a demurrage charge of Nu. 250.00 per day.



7. The successful bidder shall complete all required formalities in accordance with the Forest and Nature Conservation Act of Bhutan 2023 and its Rules and Regulations.
8. The Auction Committee reserves the right to accept or reject any bid either on the spot or at a later date. In case of any dispute arising from the auction, the decision of the Committee shall be final and binding.
9. Prospective bidders are mandated to inspect the auction lots prior to bidding. Therefore, bids shall be placed at the bidder's own discretion and judgment. No complaints shall be entertained thereafter.
10. Disposal of items through public auction shall be subject to Goods and Services Tax (GST) at the rate of 5%.
